Pursuant to Official Dispatch No. 1638/SGDHN-QLNY dated 26 June 2026 of the Hanoi Stock Exchange guiding periodic information disclosure;

Pursuant to the Reviewed Interim Financial Statements for the period from January 1, 2026 to June 30, 2026 of Dong Thap Water Supply and Urban Environment Joint Stock Company, prepared on August 14, 2026.

Dong Thap Water Supply and Urban Environment Joint Stock Company would like to explain the reasons for the profit after tax in the first 6 months of 2026 increasing by more than 10% compared to the same period last year, specifically as follows:

- Due to the expansion of the clean water supply area and other related services, clean water revenue and other revenues increased compared to the same period last year.

- From January 1, 2026, implementing Decree No. 346/2025/NĐ-CP⁽¹⁾ and Decision 525/QĐ-UBND⁽²⁾, resulting in an increase in other income from the
