(increase/decrease) in business results for fiscal year 2025–2026 compared to business  
results for the same period of fiscal year 2024–2025 as follows:

Profit after tax of Son La Sugar Joint Stock Company for fiscal year 2025–2026  
decreased by VND 182,994,043,363 compared to the same period of fiscal year 2024–  
2025, mainly due to the following reasons:

In the domestic sugar market during fiscal year 2025–2026, supply exceeded demand.  
Furthermore, due to the impact of smuggled sugar and commercial fraud, as well as an  
increase in the import of liquid High Fructose Corn Syrup (HFCS), the market was  
consistently in an oversupply state, causing sugar product selling prices to drop significantly.  
Meanwhile, effective from July 1, 2025, the VAT rate increased from 5% to 8%, leading to  
a decline in gross profit margin and consequently a reduction in net profit after tax this year  
compared to the same period of the previous year.

Son La Sugar Joint Stock Company hereby submits this document to your
